Benefit Descriptions

Trip Cancellation or Trip Interruption: Provides benefits up to the Maximum Benefit Amount shown in the Schedule of Benefits, to reimburse You for unused non-refundable Prepaid Payments You paid for Travel Arrangements when You are prevented from taking Your Trip due to a covered reason. // If you must interrupt your trip due to a covered reason, this provides benefits up to the Maximum Benefit Amount shown in the Schedule of Benefits to reimburse You for unused non-refundable land or water Travel Arrangements plus the additional Transportation Cost paid: a) to join Your Trip if You must depart after Your Scheduled Departure Date or travel via alternate travel arrangements; or b) rejoin Your Trip from the point where You interrupted Your Trip to the next Scheduled Destination; or c) transport You to Your originally scheduled Return Destination of Your Trip.

Trip Delay: Reimburses you up to \$150 per day for the non-refundable, unused portion of the prepaid expenses for your trip and reasonable accommodation, meal, telephone call, and local transportation expenses incurred if you are delayed for 6 hours or more from the original departure time and this prevents you from reaching your scheduled destination.

Medical Evacuation and Repatriation of Remains: Among other things, this reimburses transportation expenses incurred to transport you to the nearest medical facility where treatment is available if you incur a sickness or injury that is acute or life-threatening during your trip.

Baggage and Personal Effects: Covers permanent loss, theft, or damage of your baggage and personal effects.

Baggage Delay: Provides coverage if your checked baggage is delayed or misdirected by a Common Carrier for more than 12 hours from your time of arrival at a destination other than your return destination.

Emergency Accident & Sickness Medical Expense: Provides coverage if a covered accidental injury or sickness occurs during your trip.

Accident Death & Dismemberment: Coverage if you sustain a loss as a result of an injury caused by an accident occurring during your trip.

Optional - Cancel for Any Reason (CFAR): If you cancel your trip for any reason not otherwise covered by this plan, this provides benefits for up to 75% of the trip cost provided your payment/deposit for this plan is received within the time sensitive period, and you must cancel the trip 48 hours or more before scheduled departure date of your trip. Please note that you must pay an additional cost for this coverage and cannot add this coverage after your initial plan purchase. This Cancel For Any Reason Benefit does not cover failure of the Travel Supplier to provide the bargained-for Travel Arrangements due to cessation of operations for any reason.
